## The Commons

# Urban Land Management

Hermann Park requires a watchful eye and a nurturing hand across all of its 445 acres. The greenspaces are opportunities to interact with native species in the center of the City, thanks to the diligent work of our maintenance, grounds and horticulture staff in partnership with Trees for Houston, Bartlett Tree Experts, Texas Master Gardeners, Hermann Park Golf Course, Houston Zoo and Houston Parks and Recreation Department.

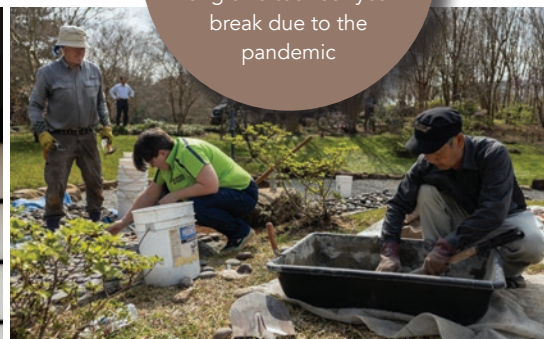
